Give Kids A Smile Ohio kickoff events bring together children, volunteers and local leaders

The Ohio Dental Association hosted Give Kids A Smile kickoff events at two locations this year in honor of the event's 15th anniversary. The first event was at the Dental Center of Northwest Ohio Van Wert Smiles location on Feb. 3, and a second event was at The Ohio State University College of Dentistry on Feb. 4.

The first kickoff event at the Dental Center of Northwest Ohio Van Wert Smiles connected children from Northwest Ohio without dental insurance coverage with volunteer dental team members. Volunteers provided preventive dental services, and volunteer dentists eliminated dental pain through tooth extractions and fillings. Volunteers provided 47 children with free dental care.

"This was great because they took out each tooth that hurt them every day and was causing them to be missing class all the time to see the school nurse," said Cheri Baer of Van Wert, whose two grandsons attended the event.

Give Kids A Smile is a national collaborative effort to provide dental care and oral health education to children without dental insurance coverage. The event was the first to be held in Van Wert.

"I am really proud to have the statewide Give Kids A Smile kickoff event here in Van Wert during my year as the Ohio Dental As-

sociation's president," said ODA President Dr. Kevin Laing of Van Wert. "I appreciate all of the volunteers giving their time and talent to provide valuable dental care to the kids in our community. Dentistry is truly a caring profession."

During the event, local leaders and Ohio policymakers, including Sen. Cliff Hite (R-Findlay) and Rep. Craig Riedel (R-Defiance),

toured the Van Wert Smiles dental center and spoke with Laing and ADA President-Elect Dr. Joe Crowley, a dentist from Ohio, about the importance of oral health and the need for proper funding of safety net dental clinics and Medicaid.

The second kickoff event was hosted

2017 ODA Day at the Statehouse gives dentists, students opportunity to educate new lawmakers

Day at the Statehouse, the Ohio Dental Association's most important grassroots advocacy event, will be April 26 in Columbus.

After last year's election, there are several new members of the Ohio General Assembly. ODA's Day at the Statehouse gives dentists, dental residents and dental students an opportunity to connect with these new members and educate them about issues important to dentistry and discuss how legislation can affect patients, dental practices and oral health in Ohio.

Attendees will be asked to discuss several issues important to dentistry at this year's Day at the Statehouse.

Outside interest groups have been pushing for the creation of a midlevel provider, or dental therapist, in Ohio. The ODA is expecting a tough fight from these interest groups this year, and it is likely that legislation will be introduced to create a midlevel provider in the near future.

A midlevel provider would receive three

years of post-high school training and would then be able to perform irreversible surgical procedures without a dentist being physically present. The ODA opposes midlevel dental providers because they do not receive adequate training to perform irreversible surgical procedures and present a risk to vulnerable patients, and the proposal is a diversion of resources that can be better utilized to support programs that are proven to improve access to dental care.

Attendees also will be asked to talk to their legislators about Senate Bill 87, which is legislation that would prohibit dental insurance

plans from setting the fees for dental services the insurance company does not cover for the enrollee. A third issue attendees will be asked to talk about is a proposal in the 2018-19 state budget to extend the sales tax to "cosmetic" dental and medical procedures. The ODA is opposed to applying the state sales tax to any dental procedures.

Day at the Statehouse will include a luncheon for attendees, briefings from the ODA advocacy team on current topics affecting dentistry in Ohio and tips on how dentists can effectively discuss those issues with legislators.

Attendees may also participate in a conference call prior to Day at the Statehouse that will provide an overview of the issues dentists will be asked to discuss with legislators during the event. Before the event, attendees will also receive written materials about the topics that will be discussed.

The Director's Chair

On Wednesday, April 26, the ODA will hold its annual Day at the Statehouse. This is organized dentistry's biggest grassroots advocacy day in Ohio. The issues this year are extremely critical to the practice of dentistry, the dental profession, and dental patients across Ohio. ODA's Day at the Statehouse gives dentists the opportunity to speak one-on-one with legislators about issues important to dentistry and advocate for patients, dental practices and oral health in Ohio.

Below is a brief overview of some of the issues we will focus on during Day at the Statehouse.

Dental therapists

The Kellogg Foundation has funded an effort in Ohio through the Universal Health Care Action Network of Ohio to promote the creation of a new provider called a dental therapist. This concept would allow a dental therapist, with just three years of training after high school, to engage in a very broad scope of practice that includes diagnosis, treatment planning, extractions, restorations, administration of local anesthesia and supervision of dental hygienists and dental assistants.

The ODA's lobbying team has diligently worked to educate policymakers on the dangers of this radical proposal. We have explained that the proposed scope of practice for these dental therapists is much too extensive for the minimal training proposed. We also explained that only a licensed dentist should perform irreversible surgical dental procedures. Moreover, this proposal would divert precious resources from other valuable oral health programs that truly improve access to quality, comprehensive dental care, such as Medicaid reform and loan repayment.

Non-covered services

In the last several years, dental insurers began telling dentists what they can charge for services the insurers don't even cover. This insurance company tac-

tic is creating hardships for dental offices and interferes with the dentist-patient relationship, often acting to limit patient choices, forcing some patients to forgo preferred treatment options or disrupting continuity of care by forcing patients to go to other dentists for certain procedures.

The ODA is supporting legislation that would prohibit dental insurance companies from being able to dictate fees dentists charge for services the insurers do not even cover.

Cosmetic medical procedures tax

Currently, the state sales tax does not apply to health care services. The proposed state budget bill for fiscal years 2018-19 would extend the state sales tax to "cosmetic" medical and dental procedures. This is a dramatic change in Ohio policy, which has consistently exempted most professional services from the sales tax. Obviously, this proposal will drive up the cost of care for Ohio's dental patients. Moreover, the proposal potentially leaves it to the Department of Taxation to determine whether a certain procedure is primarily functional or cosmetic, which would be problematic and may be detrimental for Ohio's dentists and dental patients. The ODA is opposed to applying the state sales tax to any dental services.

Tele-dentistry

The ODA is pursuing legislation to update the Ohio Dental Practice Act to better reflect the new technology that is emerging related to tele-dentistry. The legislation will permit dentists to utilize tele-dentistry to extend the reach of the dental team into underserved communities to provide valuable prevention and other oral health services and to expand the ability of the existing dental team to provide care to the fullest extent of their training. This ODA-backed bill will also expand the capacity of the Ohio Dentist Loan Repayment Program, which creates incentives for dentists to provide care to underserved populations in designated dental professional shortage areas in urban and rural communities, and target specific scholarships in the Choose Ohio First Program for dental students who agree to practice in designated Ohio underserved areas upon graduation.

oral health of the children of Ohio. Every component in the state has an event planned within their borders, and the number of counties increased to a new high of 51 from the previous high of 39. In response to this exceptional success I want to add to the chorus and express my sincere gratitude to all of the members and dental teammates who stepped up to the plate and made GKAS happen!

I was extremely proud to have a GKAS roll out event in my hometown of Van Wert. Our local Van Wert Hospital Foundation opened a dental clinic just over one year ago. The four-chair clinic is run by the Dental Center of Northwest Ohio, and they are currently in the process of adding two more operatories. Several local dentists volunteered, local hygienists volunteered, and the clinic's assistants and staff filled out the team. It was such a fulfilling experience when my elder son, who is a second year hygiene student, came up from Columbus to offer assistance. Our state senator and representative attended, as did the Van Wert City Council president. Several newspapers covered the event, and even the Lima television station covered the event. A bonus VIP guest was ADA President-Elect

A call for action

ODA Day at the Statehouse provides the opportunity for legislators to hear directly from dentists from their own communities. It is incredibly important for legislators to hear from dentists who live and practice in their districts on these issues. It is your opportunity to inform them why dental therapists are not the answer for access to dental care in Ohio. You can explain that all Ohioans deserve to receive quality, comprehensive dental care from a fully-trained licensed dentist, not some undertrained limited service technician. You will have the opportunity to educate legislators that certain insurer and third-party payer practices interfere with the sanctity of the dentist-patient relationship and that administrative burdens detract from the time dentists have to deliver care to patients. You will have the opportunity to explain the burden on patients that extending the sales tax to certain dental services will cause and the dangers of allowing government bureaucrats to decide what qualifies as "cosmetic" dental procedures in today's complex dental care delivery system.

The Day at the Statehouse begins with a briefing from ODA's lobbying team, so you will have the latest and most accurate information regarding dental-related issues under consideration by the General Assembly. Attendees may also participate in a conference call prior to Day at the Statehouse that will provide an overview of the issues dentists will be asked to discuss with legislators during the event. Attendees will also receive written materials on the pertinent issues. This year's event will be at the Renaissance hotel, which is adjacent to the Ohio Statehouse in downtown Columbus. Lunch will be provided during Day at the Statehouse, which is entirely free for ODA members.

If you have never attended Day at the Statehouse, we would be happy to match you up with a colleague who would be willing to mentor you on meeting with your legislator. It is essential that we have a significant turnout of dentists so Ohio's policymakers know that these issues are important to dentistry. Again, it was special for me because my D-1 younger son participated in the event. I was so impressed that Dean Patrick Lloyd and the administration at the College of Dentistry have chosen to use the GKAS event to allow the students to step up and assume the leadership of the activity from planning through execution.

I was able to meet with three components to bring them an ODA update.

The power of grassroots advocacy

The November 2016 election is in the rearview mirror and many Americans are happy to see politics take a back seat for a while. The reality is, however, that legislators and policymakers will continue making decisions that impact your future as a dentist.

Health care remains in the midst of transformative change and many issues important to Ohio dentists are under debate. The creation of new dental providers, increased taxes and fees, and dental Medicaid reimbursement rates and adult coverage are just some of the ideas being considered by legislative bodies throughout the country.

Politics matter, even to dentists, not just during election season but throughout the year. Fortunately, Ohio's dentists are in a strong position to positively impact this debate in a variety of ways.

First, dentists can help ensure that pro-dentistry candidates win elections and become decision-makers by supporting ODPAC. ODPAC is the political arm of organized dentistry and is the only PAC in Ohio that represents the interests of Ohio dentists.

PACs were established as a mechanism for like-minded individuals to bind together to influence elections and help level the political playing field with big dollar contributors like insurance companies and labor unions. ODPAC allows dentists to pool their individual contributions together in order to make substantial contributions to the campaigns of pro-dentist candidates who may be in a position to influence the issues that affect dental patients and practices.

ODPAC doesn't just operate in Ohio. It is a federally registered PAC and has an affiliation with ADPAC, the American Dental Association Political Action Committee, in order to help influence Congressional elections and issues on the national level.

ODPAC does not receive funds from the ODA and is funded solely from the contributions of individual Ohio dentists, their spouses and dental students. It is also non-partisan in operation. ODPAC has supported candidates of all political persuasions in the past, but those candidates all have a common thread: support for Ohio dentists and the issues of importance to dentistry.

Second, dentists can be powerful grassroots advocates. As highly trained professionals, dentists are respected in local communities. Legislators know this and they value the opinion of local dentists as constituents. Legislators also know that dentists see hundreds of their other constituents on a daily basis and are in a unique position to shape the public's impression of a politician or view on a political issue.

Dentists provide legislators with a unique source of information. Many elected officials know very little about dentistry, the delivery of health care or

ODA seeking nominations for Awards of Excellence

The Ohio Dental Association is seeking nominations for its 2017 Awards of Excellence program.

The ODA's Awards of Excellence program recognizes men and women who offer distinguished service to dentistry and improve oral health care by offering treatment, outreach or education.

Members and local dental societies are encouraged to nominate those they know who have made extraordinary efforts to improve the dental profession.

The Awards of Excellence program includes the following five award categories:

- Distinguished Dentist Award – the most prestigious of the ODA's awards, is presented to an ODA member who has demonstrated service, commitment and dedication to the profession throughout his/her career. Nominees should display leadership, dedication, commitment and outstanding contributions at the local, state and national levels.
- Achievement Award – is presented to a dentist or an individual who has made outstanding contributions to the dental profession and to oral health. Nominees are not required to be dentists, but should display a personal and professional commitment to the profession and the public's oral health. These individuals are honored as ambassadors for the profession to the community.
- Marvin Fisk Humanitarian Award – honors ODA members who offer dedication to improving oral health care in at-risk communities. Nominees may have served overseas or closer to home, spending time and often their own finances and other personal resources to help improve oral health care and fight illnesses.
- N. Wayne Hiatt Rising Star Award – is presented to an ODA member in practice 10 years or less who has demonstrated outstanding leadership and commitment to organized dentistry. ODA members who began to practice Jan. 1, 2007, or later are eligible. by The Ohio State University College of Dentistry in partnership with the ODA on Feb. 4.

At the event, 116 dental students, 40 hygiene students and 36 faculty/residents volunteered to provide \$18,969 worth of free care to 106 children.

"I'm so proud of the student leaders and all they did to organize another great event," said OSU assistant clinical professor Dr. Erin Gross. "Their dedication to Give Kids A Smile made it possible for us to provide care to the children in our community and to share our mission with our legislators and the leaders of the ODA."

State Reps. David Leland (D-Columbus) and Bernadine Kennedy Kent (D-Columbus) attended the event. Gross and OSU dental student Kyle Boyd, lead organizers of the event, gave the legislators a tour of the event and spoke with them about Give Kids A Smile. Additionally, OSU dental school Dean Patrick Lloyd and leaders from the ODA spoke to them about access to care and dental education.

"This event was one of our most successful to date," Boyd said. "It was awesome to be able to help so many children and to join with the ODA to talk to the

state representatives about the importance of Give Kids A Smile. It is one of the most rewarding volunteer experiences we students can take part in because it allows us to demonstrate how committed we are to helping children in Columbus and the surrounding area."

Since 2003 more than \$12 million in donated dental care and oral health edu-

cation has been provided by volunteers in Ohio.

"The ADA and our member dentists take seriously the need for children's oral health, and our program, Give Kids A Smile, has taken a giant leap to meet the

needs of the community," Crowley said. "We are getting kids access to care and putting them in a place where they can continue to access it in the future."

In Ohio, more than 1,900 dentists, dental professionals and educators will volunteer to educate children about good oral health and provide dental services to Ohio's underserved children.

"Over the years observing Give Kids A Smile events, one of the most rewarding things I see is the smiles on the volunteers' faces," Crowley said. "They don't take this lightly and the volunteers are engaged in the local community to continue care."



Dental Insurance Corner

Change in PPO practices illustrates need to utilize Contract Analysis Service

Over two and a half years ago a major Ohio dental insurer changed its reimbursement rate and participation obligations for newly contracted dentists.

At the time, the carrier reported it made the change in order to stay competitive with other preferred provider organizations (PPOs) that were reimbursing their contracting dentists at lower rates and, as a result, were able to charge their subscribing employers lower premiums. Dentists who joined the insurer's network after August 2014 were enrolled in the carrier's lower reimbursement rate PPO and paid accordingly. The insurer opted to not impose these changes on its existing network of dentists who were already under contract and decided to leave its payment rates and participation obligations unchanged.

While the carrier did publicly announce the changes, many dentists who were not under contract to the carrier at the time did not note the change. Similarly, many who did contract with the carrier either did not notice or appreciate the change because it did not appear to have a direct impact on their practices at the time.

Dentists are now typically finding out about the change as they either join

the insurer's network for the first time or when they go to enroll a new associate into the network. Unfortunately, it appears most of the time they actually learn of the change after they sign the contract and then start seeing claims being paid at a lower-than-expected rate. By this time their options to do anything about the situation are very limited.

"It is essential that dentists fully understand the ramifications of joining into PPO arrangements before they sign the contract," said Dr. Manny Chopra, chairman of the Ohio Dental Association Council on Dental Care Programs and Dental Practice. "Far too often we receive calls from dental offices questioning the actions of a PPO after they unknowingly signed a contract that gave the PPO the authority to act in the manner it did."

Chopra continued, "One free resource all ODA members have at their disposal is the Contract Analysis Service. Unfortunately this service is woefully underutilized. We typically only get a handful of requests a year."

The Contract Analysis Service assists member dentist in understanding contractual terms and contractual obligations before the dentist finds himself/herself legally bound by them. It takes contract legalese and translates it into easy-to-understand language that enables dentists to make informed contracting decisions.

The service identifies potentially prob-

lematic contract provisions and their possible impact on the dental practice. This information can help the dentist either negotiate more favorable contract terms or at least have a fuller understanding of what to expect as a result of entering into the agreement.

Some dentists try to negotiate more favorable PPO terms on their own while others utilize third-party negotiation services.

To utilize the Contract Analysis Service, ODA members simply need to contact the ODA Department of Dental Services at (800) 282-1526 and request an analysis for whichever contract they are considering. If the contract has already been analyzed, then the written analysis will be sent to the member at no charge. If the contract has not been previously submitted to the ODA for review, then the dentist will be asked to send the ODA an unsigned copy of the contract. The ODA will then forward it to the American Dental Association where the ADA's attorneys will analyze it. The ADA will return the completed analysis to the ODA to pro-

vide it to the member dentist, again at no charge.

Member dentists who submit analysis requests directly to the ADA are charged a \$50 fee per contract analyzed.

Dentists are also advised that it is a good idea to review the contract and its analysis with their professional liability carrier and, if necessary, legal counsel.

The Contract Analysis Service also analyzes dental management service organization (DMSO) contracts and contracts that offer dental school students scholarships or loans in exchange for a commitment for future employment.

patient receives a periodic exam along with the necessary radiographs for proper diagnosis. The treatments range from simple prophylaxis and fluoride applications to extractions and fillings. Altogether the treatments provide a unique opportunity to provide access to care to children that would otherwise not receive the care.

Beyond the care provided, the impact left on the students providing the care is just as unique. Through GKAS I have come to appreciate pediatric dentistry as an authentic test for myself as a provider. I personally love treating children and when asked why, I always profess that children offer a unique ability to challenge your communication skills, your intuition for emotional involvement as well as your clinical skill in the small space with the speed and accuracy necessary for the pediatric patient. Children can also sense your true intentions and will feed off of the emotions you bring into the operatory. The opportunity for self-improvement during the event isn't lost on me, and this is one of the many reasons I have done my best to make all of the bi-annual events at the college. I can confidently say that my bedside manner has improved as a result of participating in these wonderful events.

These skills gained through my involvement in the GKAS program have been applied in another outreach program mandatory for all fourth-year dental students called the OHIO Project. This fourth-year dental student experience is a required component of the DDS curriculum and sends students to underserved areas of the state to provide care to residents with limited access. It offers a unique experience to interact with a patient population I might not have experienced otherwise as well as a "real world" dentistry experience with assistants and a situation that is more closely associated to private practice.

This past week I was presented with a unique opportunity with one of my classmates and best friends, Mack Hoban, while on OHIO Project in Lima, Ohio. Lima Community Dental decided to undertake a GKAS event during our rotation. Mack and I were very excited, as we had both completed our last event at the college just earlier in the month. Not having done the event before, the team at Lima Community Dental had some logistical questions about the flow of the appointments to maximize the treatments rendered, and Mack and I were able to use some of the systems we employ at the school to do some good dentistry that day for some children in need. The combination of OHIO Project and GKAS was the perfect capstone to my service endeavor within dental school and was a true success.

My service involvement with both the OHIO Project and Give Kids a Smile has helped fulfill my desire to volunteer and not lose sight of the reason I chose to pursue a dental career, to help those in need.





Girls – they rule the world

The view of an independent woman has certainly changed over the years. On the shoulders of women who fought for the right to vote, we have certainly made great strides. In the '60s women were proud to "bring home the bacon and fry it up in a pan." Their interpretation of freedom was the ability to be able to earn a living but still be feminine and domesticated. Today's anthems are very different. One of my favorite quotes by Facebook VP Sheryl Sandberg pointed to the hope that "one day there will not be women leaders ... just leaders." This highlights the idea of equality and the limitless opportunities that our daughters have today, in all aspects of life. Women from all over the world, in all disciplines, of all ages have come together to advance our sisterhood and to break the "glass ceiling." This "audacity of hope" (I don't know who said this, wink ... wink) has advanced women to a position, that it seems odd to still use the term "minority."

Even in the 25 years since I started dental school, have I seen such changes. I can find role models everywhere from female chairs of post-graduate specialty dental programs like Christine Sedgely Department of Endodontology and Pamela Hughes Department of Oral and Maxillofacial Surgery at Oregon Health and Science University. I am inspired by

female deans of dental schools: Marsha Pyle from University of Missouri-Kansas City, and Cecile A. Feldman Rutgers School of Dental Medicine. Women are occupying important positions in organized dentistry, sitting on and chairing councils and committees both at state and national levels. A source of pride for Ohio is our very own Billie Sue Kyger who holds the position of seventh district trustee. In fact the incoming ODA Executive Committee in 2017 will have women in the positions of speaker of the house, vice president and secretary. The tides are definitively changing and this trend certainly echoes what we saw for the first time in Case Western Reserve University School of Dental Medicine's history: a graduation class of more than 50 percent women. No longer are women having to suppress parts of their lives to sneak under the radar in a male profession. We are studying, doing research, having children and building thriving practices all at the same time. This is because we are mentoring and guiding the women behind us to excel further and broader.

This was very evident at the last ODA

Annual Session meeting in September 2016 when I attended my first Women in Dentistry luncheon. Billie Sue Kyger, our new seventh district trustee from the ODA, led a wonderful discussion among 50 women with our outgoing ADA President Carol Summerhays. In one hour, we all shared mutual stories of the balancing act, mentors and wonderful supportive people behind our successes. One particularly touching perspective was given by a respected friend and colleague Dale Anne Featheringham. Dale Anne, an orthodontist, challenged the conventional hierarchical structure of running a practice with a domineering boss persona. She spoke very candidly about how the women in her office were not just staff but her friends. They were people she respected and offered her support and that yielded a wonderful environment for everyone, especially patients. This resonated with me as I also feel very strongly that as women, we have a responsibility to not only mentor dentists but women in general. I never miss an opportunity to take the time to help another woman advance themselves. If I can inspire a

young girl who is an assistant to go back to school and become a dentist one day ... that is purpose. If I can be sensitive to a young mother who wants to attend her child's school event ... that is purpose. If I can support a staff person through a domestic challenge ... that is purpose. When we as women make a pact to bring each other up all the time, we elevate ourselves as a whole.

So I know this column seemed very geared toward women, but it's not. At the end of the day we would not be where we are today if not for the fathers, husbands and other significant male role models who believed in the women's movement. Remember a feminist by definition is anyone who believes in the equality of women regardless of being a woman or a man.
